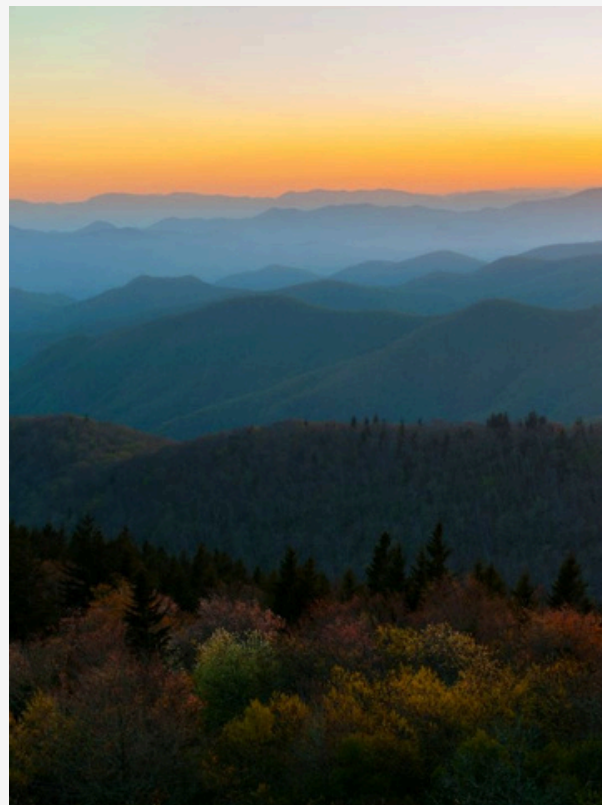

Funding Opportunity: Rediscovering Our Revolutionary Tradition

To commemorate the 250th anniversary of the Declaration of Independence, the National Endowment for the Humanities is offering up to \$350,000 for two-year projects that preserve and expand access to primary sources documenting the nation's founding and development. Eligible materials include archival records, rare publications, photographs, art, and more. Projects should focus on the history of American independence and nation-building, or the evolution of American government at the federal, state, or local level.

Collaborative Funding Opportunity: Mathematical Foundations of Artificial Intelligence

The National Science Foundation seeks proposals for collaborative, interdisciplinary research that advances the mathematical and theoretical underpinnings of AI. With awards ranging from \$500,000 to \$1.5 million over three years, this program supports projects that develop principled, mathematically grounded approaches to AI design and analysis—fostering explainable, trustworthy, and socially responsible AI.

Proposals must focus on foundational mathematical and statistical theory, while also addressing relevance to real-world applications. Teams should include expertise from mathematics/statistics, computer science, engineering, and social and behavioral sciences, as appropriate.

Don't Forget to Submit Your Sponsor-Required Progress or Final Reports

The majority of research grants have requirements for progress or final reports to be submitted by the PI. Sponsors rely on progress and final reports to track milestones, evaluate results, and ensure that funding is used as intended. Submitting these reports on time is critical to maintaining compliance and preserving good standing for future funding opportunities.

Each award comes with specific requirements, which can be found in the following ways:

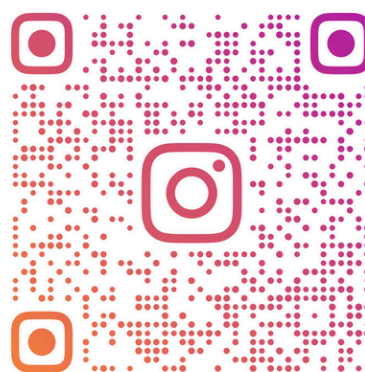
- Awarded contract/agreement

Missing report deadlines can result in serious consequences, including delays in funding, difficulty with renewals, or noncompliance issues. The Post Award team is here to help you navigate the requirements and make sure you stay on track.

The Southern Conference (SoCon) Academic Exchange is proud to announce that the annual SoCon Undergraduate Research Forum (SURF) Conference will be held on **October 24–25, 2025**, on the campus of Wofford College in Spartanburg, SC. This multidisciplinary conference will bring together approximately 150 student presenters from all ten colleges/universities of the SoCon for a two-day event that features projects in the arts and humanities, as well as the STEM disciplines.

SURF 2025 is an awesome opportunity for all students involved in research and creative activities, particularly for those involved in these activities this summer, to display their accomplishments in a variety of small, welcoming venues.

The application for SURF 2025 will be emailed to departments in August 2025. The deadline for students to submit their presentation abstracts is **Monday, September 15, 2025**.

CATALYST Program Builds Momentum in Year Two: Empowering Students Through Early Research and Leadership Engagement

The CATALYST: Summer Research and Leadership Program is set to welcome its second cohort of incoming honors students on June 24, 2025, following freshman orientation. This initiative, launched in summer 2024, is a collaborative effort between the Office of Research Administration and the Brinson Honors College.

CATALYST is a week-long immersive experience designed for incoming Honors College students. Participants stay on campus and engage in sessions that spark interest in undergraduate research and explore the intersection of research and leadership—two core touchstones of the Brinson Honors College.
