1 **WHEREAS,** Numerous students at WCU highly value access to gender-neutral restrooms; and,

3 **WHEREAS,** Western Carolina University is committed to inclusion for all students; and,

5 **WHEREAS,** Currently WCU students struggle to locate the gender-neutral and disability  
6 accessible restrooms; and,

8 **WHEREAS,** In Western Carolina University’s strategic plan 3.2.1: Build a more diverse and  
9 inclusive student, faculty and staff community to provide an environment in which all can be  
10 successful academically and professionally; and,

12 **WHEREAS,** The lack of an easily accessible way to find gender-neutral or disability accessible  
13 restrooms; and,

15 **WHEREAS,** The previously passed resolution “Addition of Gender-Inclusive Restrooms at  
16 Western Carolina University (Resolution Number S19-23)” established a need for gender-neutral  
17 restrooms on campus; and,

19 **Therefore, Be It Resolved That:** A map of the location of gender-neutral disability accessible  
20 restrooms be added to Western Carolina University’s website; and,

21  
22 **Be It Further Resolved:** That a map and poster detailing a list of each building the gender-  
23 neutral restrooms and disability accessible restrooms are located in, along with the floor number.

25 **Be It Further Resolved:** The map and poster should be found in A.K. Hinds University Center,  
26 Courtyard Dining Hall, and Brown Dining Hall.
