1 **WHEREAS**, F22-01, Updates to the Student Government Association Constitution and Bylaws  
2 established changes to the Student Senates involvement in SGA finances,

3  
4 **WHEREAS**, some areas addressing the Student Senate’s responsibility within the Supplemental  
5 Funding & Sponsorship process were not removed due to oversight in the original resolution and  
6 further reviewal found areas of confusion or contradiction; and,

8 **WHEREAS**, some areas addressing exact numbers of funding available may not be consistent in  
9 what is written in the SGA Supplemental Funding Manual, which is the most up-to-date resource  
10 of SGA Funding Policies, subject to change by the Director of Finance depending on the financial  
11 circumstances of the Organization; and,

13 **WHEREAS**, these updates have been approved by proper University officials including SGA  
14 advisors, University legal counsel, and the Vice Chancellor of Student Affairs; and,

16 **Therefore, Be It Resolved That:** The Governing Documents will be amended with the updates  
17 approved by SGA Leadership and University officials and made available to members of the  
18 organization,

23 deemed necessary by the Student Senate;” Bylaws: Art. 4, § 8 (g)



